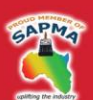

The guarantee will only apply if all surface preparation and application instructions stated on the packaging have been adhered to and the appropriate product has been selected for the appropriate application. The guarantee will not apply where the coating has deteriorated due to fair wear and tear such as inclement weather, dew, dust, grime, gas or particle pollutants, acid rain, incorrect cleaning, exceptional fungal infestation, hydrostatic or electrolyte damage, welding or other forms of heating, fire, explosions, radiation, mechanical damage, efflorescence damage, oxidation or rust, collision or other accidents, vandalism, malicious damage or damage caused by industrial action, vis major.

Powafix will not be liable for indirect or consequential damages or losses or expense of any kind; If the failed area is less than 10% of the total coated area in respect of each guarantee registration.
